Subject : Booking Charges on Deposit Quantity

This is with reference to circular no. NCCL/LOGISTICS-004/2020 dated April 7, 2020 on Warehousing Operations.

The Warehouse Space Reservation system (WSR) is available for market participants to book space before depositing their stocks in the Warehouses approved by NCCL. Accordingly, NeRL as per structure notified from time to time levies booking charges.

Members, Participants and Clients are hereby informed to take note of changes in levy of booking charges notified by NeRL vide its Circular no. NERL/OPERATIONS-005/2020/013 dated April 16, 2020, copy of which is annexed to this circular and is reproduced as under:

“Booking charges will be levied only on Deposit quantity instead of booking quantity. It implies that no charges will be levied in case the quantity booked, is not deposited. Based on Market feedback and current nationwide lockdown situation due to the outbreak of COVID 19; the said Change in levy of booking charges is applicable for all booking transactions from April 01, 2020 to May 31st, 2020.”
